- 1. Quorum for Governing Body meeting is 3 Governors or one third of the number of governors holding office (rounded up), which ever is the greater.
- 2. Quorum for committees is 3, membership is at least 5.
- 3. Staff Governors may not be members of the Management Committee.
- 4. The Chairman and the Principal are ex officio members of all committees.
- 5. Any Governor may attend any committee but, in the case of Staff Governors in relation to Personnel and Finance, this is at the discretion of the chairman of those committees.
- 6. The Performance Management Governors are, normally, made up from 3 of the chairs of committees or, otherwise any Governor, as agreed by the GB, with the Appeal Governor is the chairman.
