- Governing Board make up: up to 10 Member appointed, 1 Staff, 2 Parent, no more than 4 Co-opted, Principal.
  - Quorum for Governing Board meeting is 3 Governors or one third of the number of Governors holding office (rounded up), whichever is the greater.
  - Quorum for committees is 3, membership is at least 4.
  - Staff Governors may not be members of the Personnel Committee.
  - The Chair and the Principal are ex-officio members of all committees.
  - Any Governor may attend any committee but only members of the committee may participate in a vote. In the case of the Staff Governor attendance at Personnel is at the discretion of the Chair of that committee.
  - The appointment of the committee Chair will be confirmed at the first meeting of the committee in the Autumn term. It has been delegated to committee members.
  - If the Chair is absent from a meeting of the Committee, those present will appoint anyone present (except an employee of the Academy) to chair the meeting.
  - The term of office for Governors to serve is 4 years except for Co-opted Governors for whom the term is up to 4 years as set by the Governing Board.
  - The appraisal team for the Principal is appointed in the Summer term. Currently it is Andrew Brown, Graham Hull, Kate Shaw supported by Tony Wilson (ODBE).
