Notes

1. Quorum for Governing Board meeting is 3 Governors or one third of the number of governors holding office (rounded up), whichever is the greater.
2. Quorum for committees is 3, membership is at least 5.
3. Staff Governors may not be members of the Management Committee.
4. The Chairman and the Principal are ex-officio members of all committees.
5. Any Governor may attend any committee but, in the case of Staff Governors in relation to Personnel and Finance, this is at the discretion of the chairman of those committees.
6. The Performance Management Governors are, normally, made up from 3 of the chairs of committees or, otherwise any Governor, as agreed by the GB, with the Appeal Governor as the chairman.
7. The appointment of the committee chairman will be reviewed in the Autumn Term and has been delegated to committee members.
8. The term of office for Governors to serve is 4 years except for Co-opted Governors for whom the term is up to 4 years as set by the Governing Body.
9. The appraisal team for KEP in the Autumn term comprises Andrew Brown, Graham Hull, Kate Shaw (Governors), Jackie Cousins (ODBE) and Yvette Thomas (BC).
