### Our Remuneration

We are paid a commission by insurers unless we agree an alternative with you prior to your commitment to purchase which will always be confirmed in writing to you.

We may receive payments from insurers for work undertaken by us on behalf of insurers and which insurers would, otherwise, be required to carry out ("Work Transfer"). This may, amongst other activities, include the binding of cover, the issue and production of policy documentation and the settlement of claims within prescribed limits. These Work Transfer payments will be received and retained by us. If "work transfer" applies to your insurance arrangements this is detailed below.

Please note that no profit share income is earned on any of the insurances quoted.

Where we receive money from you or the insurer in relation to insurance placed under a delegated authority we will hold this subject to Risk Transfer. This means that when you pay us premium it will be treated as having been received by the Insurer. If the insurer pays us claims money or premium refunds this is also treated as belonging to the insurer until we remit it to you.
